National School Bus Inspection Survey Summary

Conducted During the Spring of 2011

The Survey was managed by Donald Tudor, on behalf of the NASDPTS

- The Survey had 37 states respond. (Due to an error during the first three days the survey instrument was available to states, 3 states responded that could not be identified)
- The 37 states responding either have a local inspection program (inspections done by local inspectors) or a state inspection program (inspections done by state inspectors) that are mandated by the state.
- Of the 37 states reporting, 23 states have a local inspection program mandated by the state.
- Of the 37 states reporting, 35 states have a statewide inspection program.
- Of the 37 states reporting, 9 states have both a local and a state inspection program mandated by the state.

Results of the Local Inspection Program

- Of these 23 states reporting, 19 states have state adopted inspection standards, 1 state uses the USDOT inspection standards and 3 have no adopted standards.
- On average, a bus must be inspected once every 5.06 months
- All 23 states require buses operated by public school districts to be inspected, 16 states required buses operated by private contractors to be inspected, 10 states require buses operated for

private schools either by the school or a private contractor to be inspected, 8 states require the inspection of all non-school bus vehicles operated to transport K-12 students, 3 states require the inspection to include other type buses, and 18 states require the inspection of Multi-Functional School Activity Buses.

- Of the states reporting on the items to be inspected, 15 states do not require wheels to be pulled during brake inspection, 17 do not require batteries to be tested during inspection and 16 states do not require wheels to be removed to inspect brake components; in general 19 to 21 states require a long list of common inspection items.
- The majority of these inspections are done by district staff. Of the states reporting, 13 of 23 states require state monitoring and 10 of 22 states reporting require inspectors to be certified.
- Seven states out of 23 reporting require inspection stickers to be posted on the inspected bus.
- Inspections on average require 1.10 hours to perform.

- Of these 35 states reporting, 32 states have state adopted inspection standards, 1 state uses the USDOT inspection standards, and 2 states did not respond.
- Of the 35 states reporting, 16 states require the inspection annually, 10 states require it every 6 months, 1 state requires it every 13 months, 1 state requires it three times a year, 2 states have a percentage or mileage trigger, and 3 states did not report.
- Of the 35 states reporting, 32 states require buses operated by public school districts to be
 inspected, 26 states required buses operated by private contractors, 18 states require buses
 operated for private schools either by the school or a private contractor, 9 states require the
 inspection of all non-school bus vehicles operated to transport K-12 students, 7 states require
 the inspection of other bus groups, and 24 states require the inspection of Multi-Functional
 School Activity Buses.
- Of the 33 states reporting on the items to be inspected, 18 states do not require wheels to be pulled during brake inspection, 20 states do not require batteries to be tested during inspection and 21 states do not require wheels to be removed to inspect brake components. In general, 29 to 30 of the states reporting require a long list of common inspection items.
- Of the 33 states reporting, 33 states have a standardized inspection manual or document.
- Twenty-seven states use state personnel to do the inspection, seven states allow District staff to
 do the inspections, and five states allow private contractors and private garages to do
 inspections. Twenty-nine states monitor the inspection program and 24 states require
 inspectors to be certified.
- Of the 33 reporting, 23 states require inspection stickers to be posted on the inspected bus.
- On average, state inspections require 2.52 hours to perform.
